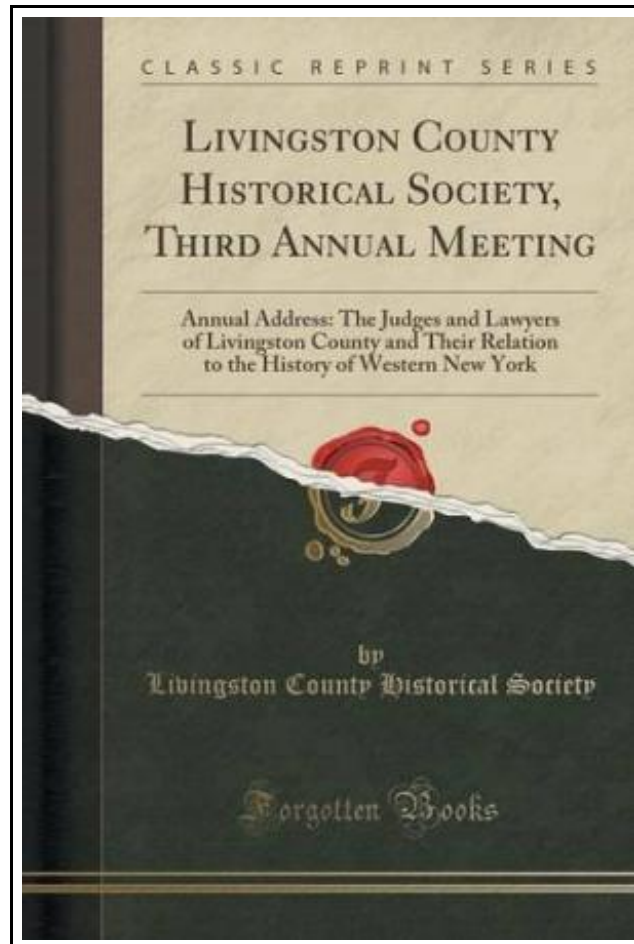

A business meeting was held at 11 o'clock a.m. at the American Hotel, Vice President Mills in the chair, Norman Seymour, Secretary and Treasurer. Letters were read from Hon. B. F. Angel, Hon. J. R. McPherson, Hon. George W. Patterson, and Thomas Warner, the latter enclosing an old round house medal. L. B. Proctor, Chairman of the Publication Committee, reported and his report was accepted. The Treasurer's report showed a balance in the treasury of \$25.08, and his report was accepted. Dr. L. J. Ames offered the following resolution, which was adopted: Resolved, That the Committee on Membership be authorized to issue a circular for the purpose of inviting citizens of the County of Livingston to become members of this Society, and that the said Committee be authorized to receive such persons as may present themselves and comply with the requirements of the Society, as members, and report the same to the Secretary of the Society, who shall enter their names on the roll of membership. On motion of A. O. Bunnell, the Secretary was authorized to procure a book for recording the proceedings of this Society since its organization, and to have the same recorded therein. The Society then elected the following officers for the ensuing year: President - M. H. Mills. Vice President - William M. White. Secretary and Treasurer - Norman Seymour. Councilmen - L. B. Proctor,...
